

Your health plan offers Transplant Resource Services (TRS), which gives you access to the nation's leading transplant programs through the Transplant Centers of Excellence (COE) network. This program helps to ensure your transplant treatment is based on best practices, and provided by health care professionals with extensive, specialized knowledge. In addition to the COE network, eligible members are paired with nurse case managers who have transplant experience. They can help you understand your transplant benefits and help make sure medically needed services are accessible as stated in your health plan. They work in coordination with your physician(s), your transplant facility and your family to help you through the entire transplant process.

Choosing a Transplant Centers of Excellence provider

TRS has developed rigorous qualification standards for providers of complex medical care. Programs are evaluated and selected based on meeting clinical criteria in the following areas:

- Involvement in improvements to the transplant treatment and process
